




Advanced Registered Nurse Practitioners (ARNPs)

Advanced registered nurse practitioners (ARNPs) include nurse anesthetists, nurse midwives, and nurse practitioners. In Washington State, ARNPs must also hold active registered nurse licenses. The following Washington statistics were calculated based on data from the ARNP license files, which contain licensee name, mailing address, age, and gender.

Licensed ARNPs per 100,000 Population*




